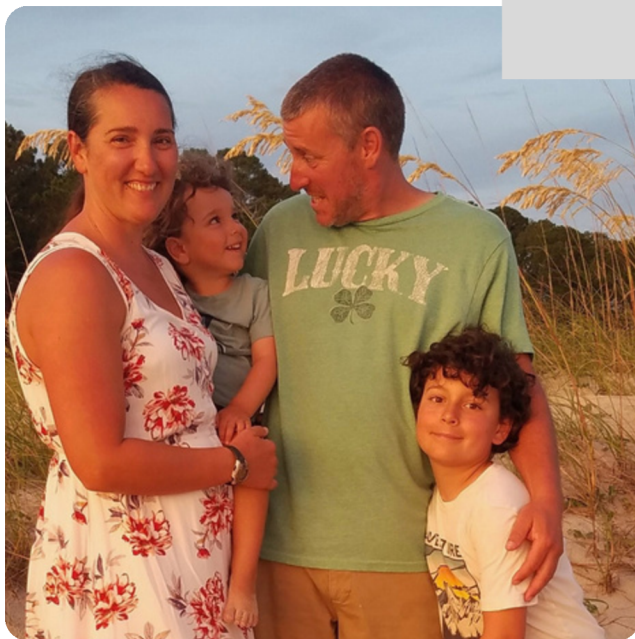




# Board Of Directors - Treasurer

# Board Of Directors - Director of Operations

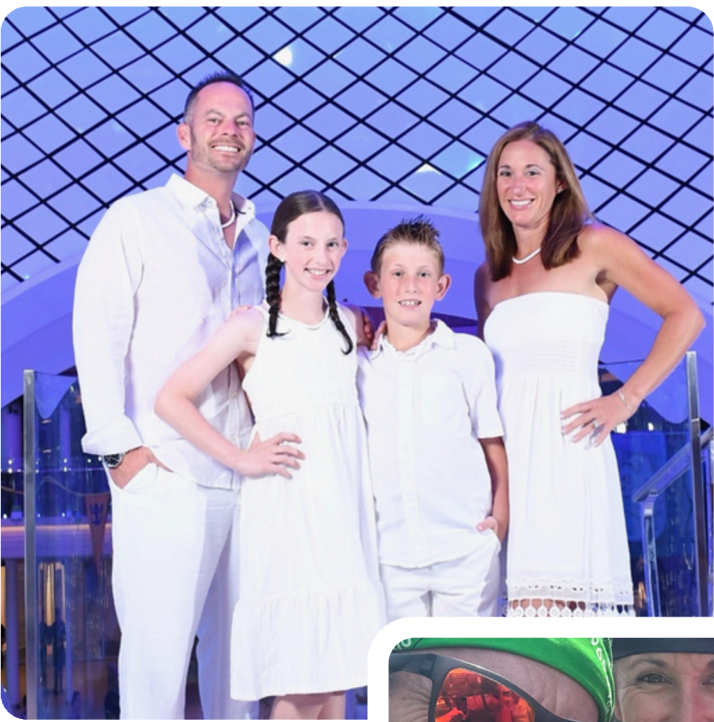


**Anthony Fairweather**
